The YAK Torsa UTV is warranted to the original purchaser to be free from defects in material and workmanship from the date of purchase for the time periods listed as follows:

- 1 year or 2,000 miles (whichever occurs first) for powertrain. (As long as prescribed regular maintenance is performed.)
- 2 years or 4,000 miles (whichever occurs first) for high-capacity LFP battery. 12-volt battery not included.
- 90 days for rental use.
